

2025 LASERNETUS MEETING

In consideration of marketing and sponsorship acknowledgments in the events and activities at the 2025 LaserNetUS Meeting on July 8-10, 2025, the undersigned, intending to be legally bound as an individual and on behalf of Sponsor, agrees:

2. that Sponsor will hold harmless the State of Maryland, the University of Maryland, and their departments, officers, agents, employees, and volunteers, the Board of Trustees of the Leland Stanford Junior University, or any of its Officers, Directors, employees, agents or assignees (the Co-Hosting Universities), and the U.S. Department of Energy or any of its Officers, Directors, employees, agents or assignees (DOE) for any and all claims relating to Sponsor's sponsorship of the 2025 LaserNetUS Meeting;
3. that the undersigned, as an individual and on behalf of Sponsor, covenants not to sue the Co-Hosting Universities or DOE for any loss, damage, expense, and liability and/or claims resulting from, arising out of, related to, or in any way connected with activities relating to Sponsor's sponsorship of the 2025 LaserNetUS Users' Meeting, including but not limited to equipment delivery, installation, exhibition, removal of banners, and other related events and activities of Sponsor at the 2025 LaserNetUS Meeting;
4. that Sponsor's sponsorship of this event will not influence the Co-Hosting University's future procurements or business relationships and that Co-Hosting Universities may make a statement similar to the following: "The organizers of the 2025 LaserNetUS Meeting gratefully acknowledge the support of the Sponsors and Exhibitors. This does not constitute an endorsement of this or any sponsors' products or services";
5. that if any part of this Agreement is held to be illegal or otherwise unenforceable, the remainder of this Agreement will remain valid and in full force and effect.
