

2025 LASERNETUS MEETING

In consideration of being permitted to participate in the events and activities at the 2025 LaserNetUS Meeting on July 8-10, 2025, the undersigned, intending to be legally bound as an individual and on behalf of Exhibitor, agrees:

1. that the anticipated activities may involve risk of injury to person or property, which might result not only from the undersigned's own actions, inactions or negligence, but the action, inaction or negligence of others, or the condition of the premises or of any equipment used, or risks not known or not reasonably foreseeable at this time;
2. that the undersigned, as an individual and on behalf of Exhibitor, its officers, directors, managers, employees, agents and assignees assume all the foregoing risk and accept responsibility for all loss, damage, expense, and liability and/or claims resulting from or arising out of, related to, or in any way connected with such personal injury, property damage, or economic loss;

4. that the undersigned, as an individual and on behalf of Exhibitor, covenants not to sue the Co-Hosting Universities or DOE for any loss, damage, expense, and liability and/or claims resulting from, arising out of, related to, or in any way connected with the equipment delivery, installation, exhibition, removal, and other related events and activities of Exhibitor at the 2025 LaserNetUS Meeting;
5. that Exhibitor shall indemnify and hold harmless the Co-Hosting Universities and DOE for any and all loss, damage, expense, and liability and/or claims resulting from, arising out of, related to, or in any way connected with Exhibitor's activity or the activity of the undersigned in relation to the 2025 LaserNetUS Meeting;
6. that Exhibitor's participation in this event will not influence future procurements or business relationships of the Co-Hosting Universities and that Co-Hosting Universities may make a statement similar to the following: "The organizers of the 2025 LaserNetUS Meeting gratefully acknowledge the support of the Sponsors and Exhibitors. This does not constitute an endorsement of this or any sponsors' products or services";
7. that if any part of this Agreement is held to be illegal or otherwise unenforceable, the remainder of this Agreement will remain valid and in full force and effect.
